

### DAY 1 SOE MEETING WITH POLICE MINISTER AND HEALTH MINISTER

#### Background

Business representatives met with Police Minister and Health Minister. Since the issuance of our *Advisory Note to Members on the State of Play under the COVID 19 State Of Emergency* last night, there have been a total of 18 queries from businesses right across the country. Several were duplicates and we will answer them collectively for the purposes of this circular. Nonetheless, our staff will respond to all queries via email.

Are PNG citizens able to travel from international flights back to PNG.	As per the State Of Emergency Rules, the answer is no. However, if the person is of high value in ensuring essential service is to continue, Minister of Health may grant exemption. This request will be determined after best available information is submitted to Minister for his urgent consideration.	Businesses are advised to submit all letters to the business reps of NOC 19 who will urgently relay to SOE Controller, Ministers of Police and Health for their feedback.
Chartered flights or other flights with passengers to travel between provinces.	As per the State Of Emergency Rules, the answer is no. However, if the person is of high value in ensuring essential service is to continue, Minister of Health may grant exemption. Liquor Ban in Eastern Highlands Province	Police Minister will consult with Eastern Highlands Governor and will respond tomorrow. Note such powers are vested with provincial gov't.	Minister will update tomorrow 10am on his consultation with Eastern Highlands Governor.
Restriction on the movement of cargos from provinces by police.
